



Terms and Conditions

Huawei ICT Competition

1.1 General

The organizer of the Huawei ICT Competition is Huawei Technologies Switzerland AG, Waldeggstrasse 30, 3097 Liebefeld, Switzerland (hereinafter: "Huawei").

By participating in the competition, the participant (hereinafter: "Participant") has read and explicitly accepts these conditions for participation.

1.2 Participation & Prize

The competition starts on 31st July 2020 10:00 AM and closes on 31st July 2020 5:30 PM (according to the details on <https://huawei-events.ch/huawei-ict-competition/anmeldung>). Participations after this date and time will not be considered.

Eligible persons are those who have already reached the age of 18 years at the time of participation, are resident in Switzerland and have a valid Huawei Certificate (HCPA, HCIA, HCSA, and HCS).

Participants must register for the competition on the website mentioned above and choose one or multiple of the four exams (Pre – Sales IT & IP, Post – Sales IT & IP). There are various prizes to win.

In order to win a prize the Participant has to take part in one of the exams listed in the subscription mask and reach at least 40% of the maximal points. The exams will be held online by our partner K Labs. Further information will be provided by K Labs. For each exam category one winner will be selected and will be able to participate in the regional competition held on October 9th and organized by Huawei Technologies Düsseldorf, Hansaallee 205, 40549 Düsseldorf, Germany.

1.3 Selection

The lucky winner(s) will be selected according to their scores. The draw for the winners will not be open to the public. Winners will be notified via e-mail from their Huawei Channel Manager. The winners will receive the prize by post or directly from their Huawei Channel Manager or Service Manager.

1.4 Duty of cooperation

The winner(s) is obliged to cooperate for the further processing of / executing this competition. If no feedback/response from the winner is received by Huawei Technologies Switzerland AG within 48 hours of e-mail notification, a new winner may be selected. It falls within the winner's responsibility to regularly check its e-mail including spam folder. No cash equivalent to the prizes will be offered. The prize cannot be transferred to other individuals.

1.5 Exclusion and dismissal of Participants

Individuals working for Huawei or involved in the design and implementation of the competition are excluded from participation. Huawei is entitled to exclude individuals from participation for such causes as the breach of these terms and conditions, submission of incomplete or wrong data or any attempted manipulation of the contest results.

1.6 Use and handling of Personal Data

Your Personal Data provided to Huawei when participating in this competition will only be used for the proper execution and further processing of the competition. For that purpose the collected Data will be transferred to the Huawei subsidiary in Germany which organizes the regional competition in the final stage and further to our partner K Labs located in Via Salgari 17, 41100 Modena, Italy. Furthermore, your Personal Data will be processed in line with Huawei's Privacy Policy which can be found at www.huawei.com/en/privacy-policy and in accordance with Swiss law.

1.7 General conditions

Huawei can make adjustments to the competition at any time. Huawei reserves the right to cancel the competition if compelling conditions arise or based on important reasons. An example of compelling conditions might be where it becomes impossible to guarantee that the competition can be run correctly due to technical or legal reasons.

Should individual provisions of the conditions of participation be or become invalid, this shall not affect the validity of the remaining conditions of participation.

There is no right of appeal.

This competition is subject to Swiss law. The competent court of jurisdiction is Zürich.
